#### The Commission's Third Report on Statute Law Revision

The Honourable W. E. Knox, M. L. A., Minister for Justice and Attorney-General, BRISBANE.

This is the Third Report submitted by the Law Reform Commission concerning statute law revision. The previous two Reports were numbered Q. L. R. C. 11 and Q. L. R. C. 15 and the recommendations in those Reports were implemented in the New South Wales Acts (Termination of Application) Act 1973 and the Acts Repeal Act 1973 respectively.

The first of these Acts terminated the application, in so far as Queensland was concerned, of 478 Acts passed by the New South Wales Parliament and which became Queensland legislation upon Separation in 1859.

In preparing its Second Report the Commission carried out an examination of all Queensland Acts passed between 1860 and 1971. It recommended in such Report that a number be repealed and subsequently 287 of these were included in the Acts Repeal Act 1973.

Further enquiries have been made from Government Departments, semi-Government bodies and private concerns in relation to a number of other Queensland Acts and the replies received to date indicate agreement with the Commission's recommendation that the 124 Acts listed in the enclosed Schedule to the draft Bill (Schedule I) also be repealed. The reasons for the Commission's recommendations in regard thereto are set out in Schedule II. Some enquiries made still have not been answered, so there remain a number of other Acts which it may also be possible to repeal. If this is the case they will be the subject of a subsequent Report.

It is also intended in due course to submit a Report recommending which of the Imperial Statutes applying to Queensland by virtue of s. 24 of 9 Geo. IV c. 83 (Australian Courts Act 1828) could be repealed.

17th March, 19 BRISBANE. A Bill to Repeal certain Acts passed by the Legislature of Queensland.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:-

- 1. Short title. This Act may be cited as the Acts Repeal Act 1975.
- 2. Repeals. The Acts set out in the Schedule to this Act are hereby repealed.
- 3. Savings. The repeal by this Act of the Acts set out in the Schedule does not -
  - (a) revive anything not in force or existing at the commencement of this Act;
  - (b) affect the previous operation of, or anything duly done or suffered under, any Act so repealed;
  - (c) affect any right, privilege, obligation or liability accrued, acquired or incurred under any Act so repealed;
  - (d) affect any penalty, forfeiture or punishment incurred in respect of any offence committed against any Act so repealed;
  - (e) affect any investigation, legal proceeding or remedy in respect of such right, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid and any such investigation, legal proceeding or remedy may be instituted, continued or enforced and any such penalty, forfeiture or punishment may be imposed and enforced as if this Act had not been passed;
  - (f) affect the operation of any amendment made by any Act so repealed to another Act; or
  - (g) affect the operation of any provision for the citation of another Act as amended by any Act so repealed.
