Models of Participation

This paper shows different ways that people might tell the Government what they think BEFORE it decides about a **Omining proposal**. These ways are called Models of Participation.

We want to hear what you think about these different models.

Aboriginal and Torres Strait Islander Advisory Committee





A working group that gets ideas from Aboriginal peoples and Torres Strait Islander peoples and finds out what they want Government to know, before it decides about a imining proposal

- All members are Aboriginal peoples and Torres Strait Islander peoples
- Gives advice or help, or suggests changes about a imining proposal
- Can choose to give advice about culture (e.g. cultural heritage) or other things

Community advisory committee or reference group





A working group that gets ideas from locals and tells Government about what might happen in their community if a imining proposal goes ahead

- The Government chooses interested members of the public
- It has 2 jobs
 - 1) find out what people in the community think and tell Government about this
 - 2) tell Government about good or bad things that might come from a mining project, and what to do about them
- Members understand the local community and environment

Community leader council





This group helps to point out problems and to work together to find ways of fixing problems that might come from a mining proposal

- Like a community advisory committee or reference group (Model Number 2) but the members are leaders from interested groups
- This group will be looking for good changes that locals or Aboriginal peoples and Torres Strait Islander peoples and their communities will get for the **economy* or people

Written submissions or comments



A paper that says what a person or organisation thinks about a imining proposal

- The Government might ask for this at different times
- Might be made public
- Might be given to Government or to the i miner
- The Government might tell the i miner it must give an answer to these written i submissions or comments

Information session or open house





A public meeting when people can find out about the imining proposal and how the Government will decide about it

- Might be face-to-face or online, or both
- Might be more than one session
- Mostly the Government or the iminer giving information to the public about a imining proposal
- The Government might organise the meeting, or the iminer might do it

Public meeting





A meeting for locals to say what they think about a imining proposal – like what they are not sure about or worried about. And also to give ideas about what needs to change

- Mostly about people having the chance to talk, while the Government listens to their ideas about a imining proposal
- There are different ways a public meeting might happen.
 Sometimes there might be strict rules, for example about how many minutes people can talk for. Sometimes the Government might tell some people they must be at the meeting, and be ready to answer questions
